Field of activity: care for persons with disabilities

Sexualized violence against women and men with disabilities

Subject:

Women and men with disabilities are affected by sexualized violence more often than people without disabilities.

Some of the reasons for this is living in systems directed by others and a higher level of dependence on others. Comprehensive knowledge, awareness of possible suspect cases and the right intervention measures protect, help and strengthen the parties concerned and the responsible care givers and assistants.

Objectives:

Participants gain fundamental knowledge about sexualized violence. They acquire the ability to perceive suspect cases and react to them adequately. Guidelines and intervention plans are to be conveyed and discussed

Content:

- Clarification concerning the terms, distinction between border violation / sexual infringement
- Violence dynamics and offenders' strategies
- Symptoms and possible indicators
- Dealing with suspect cases, guidelines and intervention plans

Prevention and self-determination in pedagogical everyday life

Subject:

Prevention should be an integral component of pedagogical action. In many organizations preventive approaches already exist. They are to be discussed, reflected and expanded.

Objectives:

Participants gain fundamental knowledge about the different fields of prevention and acquire the ability to act in a preventive manner in everyday education.

Content:

- Victim AND offender prevention
 - Fields of primary prevention (sex education, body, boundaries ...) and practical transfer thereof as well as implementation in everyday education (methods, games, exercises, media...)
 - Sexual infringements among women and men with disabilities: perceiving and handling
 - Gender-specific offers in the organization

Sex education support for women and men with disabilities as a specific field of prevention

Subject:

Women and men with disabilities often have difficulties in developing and living out their sexuality according to their wishes, needs and skills.

This results in diverse challenges and tasks for organizations in the aid sector for the disabled but also for the daily care work.

Objectives:

Participants gain fundamental knowledge about possibilities of sex education support and can, with a practical orientation, reflect their own sex education competencies.

Content:

- Sex education support: objectives, framework and conditions
- Development of human sexuality
- Reflection of personal approaches and attitudes, norms and values concerning sexuality
- Methods and material for practice
- Real-life examples

Special risk factors in organizations that help the disabled

Subject:

Organizations hold special structural risk factors. In order to reduce sexual violence in institutions, risk factors have to be recognized at all levels (staff, team, organization). These risk areas can be perceived as learning fields for development and improvement.

Objectives:

Participants acquire the ability to analyze different risk factors and perceive the possible chances for development and improvement for themselves, their team and the organization itself.

Content:

- Organizational structures and working conditions
 - Participation and complaint management
 - "Safe" space
 - Pedagogical and sex education concepts
 - Supporting systems and ombudsmen
 - Working with the relatives

Legal basis for the staff of the aid sector for the disabled

Subject:

Sexualized violence and criminal law

Objectives:

Participants gain an overview over the Austrian law concerning the protection against sexualized violence as well as information about the support available during and around the process and victim protection.

Content:

- Laws on protection against violence
 - Obligation to inform and notify
 - Victim protection laws, Process support
 - Questions of liability

Methods:

Inter alia: lectures, worksheets, working in small groups, training self-reflection skills, feedback and error culture, etc.

Framework:

- Ideal group size: 8 to 24 participants
- Date and place by agreement

Timeframe:

- 6 hours per training

Costs:

- € 780 per further training: incl. documentation, plus travel expenses
